The Police Department has reviewed the Machiavelli's temporary beer permit renewal applications for compliance with the following requirements:

Signage and Posting: Not applicable due to being a temporary site.

Publication: Not applicable due to being the renewal of an existing permit.

Zoning Compliance: The location of the temporary beer establishment is compliant with zoning pursuant to Section 6-145(b) by being in a B-2 or a B-3 zone.

Special Distance Separation: The Distance separation requirement provided in Section 6-145(c) satisfied for this on-premises permit with a distance separation of more than 150 feet from any school (public or private) and any church located in any residential zoning district, as measured on a straight line from the nearest property line of any school or church to the nearest point of the building of the temporary beer permit.

Criminal Checks: A local criminal background check of the owner(s) pursuant to Section 6-147(5) has been undertaken to verify that owners comply with the "good moral character" requirements and have not been convicted within the past ten years of violations of any laws or ordinances against manufacturing, selling, transporting, storing or possessing intoxicating liquor

of alcoholic content in excess of five percent by weight, and have not been convicted of a felony within the past ten years.

Other Adverse Factors: There are no known factors to the Police Department associated with the proposed location that may have an adverse effect in consideration of the type and character of the neighborhood; the population density of the neighborhood; the proximity of residences, schools, parks, and playgrounds; the proximity of churches or other religious establishments; or any problem with law enforcement in the area; or any other factors which affect the public health, safety, or welfare.

An application fee of \$100 per application for a total of \$800 has been received by the City for this permit.

Based on the foregoing, this applicant appears to meet the requirements to apply for a permit under the Beer Ordinance. Therefore, it is staff recommendation that the permit be considered, unless the Beer Board finds disqualifying grounds at the hearing on the application.

Subject: Express Mart Beer Permit Application

The Police Department has reviewed the Express Mart beer permit application for compliance with the following requirements:

1. Signage and Posting: Proper signage and posting time have been satisfied at the site as of 02/25/2021.
2. Publication: Proper legal notice was published in the Bristol Herald Courier on 03/14/2021
3. Zoning Compliance: The location of the beer establishment is compliant with zoning pursuant to Section 6-145(b) by being in a B-1B Neighborhood Shopping zone.
4. Special Distance Separation:
Special Distance Separation is not applicable for this Off-premises permit.
5. Criminal Checks: A local criminal background check of the owner(s) pursuant to Section 6-147(5) has been undertaken to verify that owners comply with the "good moral character" requirements and have not been convicted within the past ten years of violations of any laws or ordinances against manufacturing, selling, transporting, storing or possessing intoxicating liquor of alcoholic content in excess of eight percent by weight, and have not been convicted of a felony within the past ten years.
6. Other Adverse Factors: There are no known factors to the Police Department associated with the proposed location that may have an adverse effect in consideration of the type and character of the neighborhood; the population density of the neighborhood; the proximity of residences, schools, parks, and playgrounds; the proximity of churches or other religious establishments; or any problem with law enforcement in the area; or any other factors which affect the public health, safety, or welfare.

An application fee of \$250 and the publication costs for the permit process have been received by the City for this permit.

Based on the foregoing, this applicant appears to meet the requirements to apply for a permit under the Beer Ordinance. Therefore, it is staff recommendation that the permit be considered, unless the Beer Board finds disqualifying grounds at the hearing on the application.
